## LICENSE AMENDMENT No. 1

Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters and the Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board hereby grants the following license amendment.

The License issued February 16, 2007 with a License expiry date of July 31, 2007 shall be amended to include terms and conditions, with respect to use of water and deposit of waste for an undertaking classified as Municipal, to allow for the relocation of the camp to a location near kilometer 47.5 and to extend the expiry date to December 31, 2007.

Amend the following:

1. **License 3BC-TEH0707:** Amend expiry date to read December 31, 2007;
2. **Part A: Scope, Definitions and Enforcement:** Amend Scope to read: This License allows for the use of water and the disposal of waste for an undertaking classified as Municipal at the new camp at a location near kilometer 47.5 of the newly constructed road;
3. **Part C: Conditions Applying to Water Use:** Amend Part C, Item 1 to add: Water will be provided by the Hamlet of Baker Lake or by trucks operated by the Applicant;
4. **Part G: Conditions Applying to Spill Contingency Planning:** Amend Part G Item 1 to read: The Licensee shall, within thirty (30) days of issuance of this amendment, submit to the Board, an updated Spill Contingency Plan to reflect the new camp location and address concerns raised in the comments received during the review process;
5. **Part H: Conditions Applying to Abandonment and Restoration:** Amend Part H, Item 1 to read: The Licensee shall, within thirty (30) days of issuance of this amendment, submit to the Board for approval, an Abandonment and Restoration Plan to include the original camp and the new camp location;

**All remaining terms and conditions of the License 3BC-TEH0707 Type "B" dated February 16, 2007 still apply.**
