- 1) Question – are the streams within the municipal boundaries?
- 2) Question – are the streams fish bearing?
- 3) Department of Fisheries authorization will be required – please contact them for proper authorization – contact is Amy.Liu@DFO-MPO.GC.CA
- 4) Please note that the current licence for the Hamlet of Arctic Bay expires at the end of March, 2010 and there is a requirement to submit a renewal immediately as our normal process time is approximately 3 months, depending on whether or not a full and complete application is received.
- 5) Attached is a questionnaire that will be necessary to submit for the stream crossings.
- 6) If this is going to be an amendment to the Hamlet's current water licence it is necessary to begin the process as soon as possible and our office may consider it to be a renewal/amendment.
