Hi Bhabesh,

We would need about 11.4 m3 /day for a 60 person construction camp.

Hi Bhabesh,

Thank you for taking the time to speak with me today; I wanted to follow up our phone conversation with a quick email.

As I explained, the Department of National Defence is currently in the planning and design phase for the construction of the Nanisivik Naval Facility(NNF). During the preliminary planning it was determined through consultation with the Hamlet of Arctic Bay that the community would be willing to enter into an agreement to supply the NNF Construction Contractor with water and wastewater services for the construction camp. During the Nunavut Impact Review Board evaluation process DND received comments from AANDC's lan Parsons highlighting that the community of Arctic Bay did not have a valid Water Use Licence. This was confirmed by the Nunavut Water Board's Director of Technical Services, David Hohnstein. Our project has been advised by both the NWB and AANDC that as long as the Hamlet of Arctic Bay's Water Use Licence is expired the Hamlet would not be in a position to enter an agreement to supply water to NNF's contractor. Further to this, if we did receive water/wastewater services from the Hamlet while their licence was expired it would be in further contravention of the Act. Today's phone call to you was to give us some idea as to when you expect Arctic Bay's Water Use Licence to be renewed; thereby when the Hamlet would be in a position to enter an agreement for water/wastewater services.
