Thanks for your email.

Please see the [eBuilder link](#) for the updated Solid Waste Disposal Facility O&M Plan, which addresses the conditions F-2 and F-3. My apologies that it was not uploaded upon initial submission of the Water Licence Amendment and Renewal application.

As for the condition F-2, as iterated in the compliance plan and amendment justification letter, it is our intention to provide a O&M Plan for the Water Supply Facility / Truck-fill Station at least six (6) months prior to commissioning of the new Water Supply Facility. The new water treatment plant is scheduled to be commissioned during Fall 2027. We hope this is a satisfactory resolution. The O&M Plan for the new water treatment plant would supersede the existing O&M Plan and follow the approved template by the NWB to address the previous comments of the issues with the existing O&M Plan.

I have also uploaded an updated version (version 2) of the Environmental Emergency Contingency Plan, Sewage Disposal Facilities O&M Plan, and Environmental Monitoring and QA/QC Plan as there were minor updates required that were identified later.
