The Nunavut Water Board acknowledges receipt of the submission of the following plans:

- Arctic Bay Environmental Emergency Contingency Plan November 2024 with Appendices.
- Arctic Bay Environmental Monitoring and QA QC Plan November 2024 with Appendices.
- Arctic Bay OM Plan Sewage Disposal Facility November 2024 with Appendices.

In the previous Licence the following conditions of Part F: items 2, 3 and 4 (mentioned in detail below) were due within (90) days following the issuance of the Licence, we did not receive these. Once received, this application will be ready for review.

- Part F. 2) The Licensee shall implement the Manual entitled "Arctic Bay Truckfill Operations and Maintenance Manual" dated 1998 that was submitted as additional information with the Application. The Licensee shall submit to the Board for approval in writing, within ninety (90) days from the date of issuance of this Licence, an updated Operations and Maintenance Manual for the Truck-fill Station to address the comments received during the review of Application.
- Part F. 3) The Licensee shall implement the Plan entitled "Solid Waste Operation and Maintenance Plan for Hamlet of Arctic Bay" dated August 2019 that was submitted as additional information with the Application. The Licensee shall submit to the Board for approval in writing, within ninety (90) days from the date of issuance of this Licence, an updated Operations and Maintenance Plan for the existing Solid Waste Management Facility prepared, where appropriate, in accordance with the Guidelines for the Preparation of an Operation and Maintenance Manual for Sewage and Solid Waste Disposal Facilities in the Northwest Territories; 1996 that addresses the comments received during the review of Application. and;
- Part F. 4) The Board has accepted the Manual entitled "Hazardous Waste Segregation, Storage and Transportation Procedure, Municipality of Arctic Bay" dated June 2019 that was submitted as additional information with the Application. The Licensee shall incorporate these Procedures into the Operations & Maintenance Manual for the Solid Waste Disposal Facility required under Part F, Item 3 and submit the updated document to the Board for approval in writing within ninety (90) days from the date of issuance of this Licence.
