Comments:

A. Background

On May 12, 2014, the Nunavut Water Board (NWB) provided notification of the Hamlet of Arctic Bay's (the "Licensee") application to renew Water Licence #3BM-ARC0810 to allow for the use of water and deposit of waste for municipal undertakings.

Interested parties were asked to review this application and provide comments by June 12, 2014.

B. Results of review

On behalf of Aboriginal Affairs and Northern Development Canada (AANDC), the following comments and recommendations are provided:

1.	Licence Term
	Comment: Block 25 of the submitted water licence application form requests a ten year licence. Due to ongoing compliance issues it is recommended that the licence term be shorter and consistent with other municipal water licence terms.
	Recommendation: It is recommended that the water licence be renewed for five years.

2. Engineering Inspection

Comments

The May 3, 2014 Plan for Compliance states that a geotechnical assessment report will be provided by March 31, 2015. This is a requirement of Part F, Item 3 of the licence that has yet to be submitted.

Observation

AANDC will review this engineering assessment report once it is made available for review.

3. New Sewage Lagoon Assessment Report

Comments

The May 3, 2014 Plan for Compliance states that a geotechnical and geothermal assessment report will be provided by March 31, 2015. This is a requirement of Part H Item 15 and further described under Part B item 1(v) of the licence that has yet to be submitted.

Observations

AANDC will review this assessment report once it is made available for review.

4. New Sewage Lagoon Effluent Monitoring

Comments

The Licensee states that they will decant the sewage lagoon once a year and sample the effluent at the end of the filtered wetland before it enters the ocean for compliance. It is unclear in the Operation and Maintenance Plan what contingencies are in place to stop the effluent from reaching the ocean if the samples are in non-compliance. Furthermore it is also unclear through the Operation and Maintenance Plan whether or not the filtered wetland will be considered a point of control by the Inspector. Unless the filtered wetland is engineered and structured in such a way that it is deemed to exact control on the effluent and provide treatment then the last point of control will be deemed the exit for the lagoon and this is where compliance limits should be met

Recommendation

AANDC recommends providing evidence that the effluent can be stopped from entering the environment if effluent limits are not met.

Also AANDC recommends that the Licensee provide evidence that this is an engineered wetland designed for the purpose of effluent treatment, and not just using the area downstream of the lagoon as an extra means of treatment.

5. Instrumentation and Surveillance Monitoring Plan

Comments

The May 3, 2014 Plan for Compliance states that a Instrumentation and Surveillance Monitoring Plan will be submitted with the 2014 Annual Report to be submitted by March 31, 2015. The existing (currently expired water licence) states that this plan was to be submitted to the

Nunavut Water Board within 30 days of the issuance of the licence amendment. This is a requirement of Part H Item 14 and 16 of the licence that has yet to be submitted.

Observations

AANDC will review this monitoring plan once it is made available for review.

6. Hazardous Waste Management Plan

Comments

The May 3, 2014 Plan for Compliance states that a Hazardous Waste Management Plan will be provided by June 30, 2014. This is a requirement of Part F, Item 1 of the licence that has yet to be submitted.

Observations

AANDC will review this management plan once it is made available for review.

7. Solid Waste Operation and Management Plan

Comments

The Licensee has not prepared a Solid Waste Operations and Management Plan as required by Part F, Item 1 of the licence. The May 3, 2014 Plan for Compliance states that this plan won't be available until March 31, 2015 and indicates that a new site will be constructed (section B-12 of the Plan for Compliance). Furthermore, the Plan for Compliance (section B-12) states that a manual for the segregation of wastes will be available for review by June 30, 2014.

Observations

The Licensee should update the NWB on its plans to manage the current landfill (i.e., waste segregation and management) and to develop a new landfill. AANDC will review these plans once it is made available for review.
