Comments: The Municipality of Arctic Bay treats water from Marcil Lake as it is loaded into trucks for distribution. No records were found regarding the treatment or monitoring of chlorine levels. Consumption records were also not available for review during the Inspection. The pumping station was clean but had an overwhelming odour of Chlorine in the building. Ice was still present on the Lake during the Inspection.

Comments: Sewage within the Lagoon was below the required 1 meter of freeboard. Obvious signs of erosion and failure of the lagoon walls were photographed during the Inspection. Downhill of the lagoons it was noted that work on retention berms had continued to slow the flow of sewage released from the Lagoon's 2 cells. Over 200 meters from the lagoon samples containing obviously high levels of sewage were collected 10 meters from the culvert outfall to the ocean.
