A list of unauthorized discharges and summary of follow-up action taken; Leachate is an uncontrolled discharge. Leachate is tested 3 to 4 times in summer prior to final discharge. vi. A summary of any abandonment and restoration work completed during the year and an outline of any work anticipated for the next year; No abandonment and restoration works was conducted during this reporting year. Not expected in next 2 to 3 yrs. vii. A summary of any studies requested by the Board that relate to waste disposal, water use or reclamation, and a brief description of any future studies planned. Segregation of wastes and management of the Hazardous wastes are the major concern and priority of the Municipality of Arctic Bay to comply with the conditions and criteria of the Water licence. A feasibility study is expected in 2-3 yrs. in order to build a new waste management facility. Any other details on water use or waste disposal requested by the Board by November viii. 1st of the year being reported; and The existing waste management site is a big concern. Right now Hamlet is segregating wastes in proper manner. Batteries are being stocked in the sea scan for the future disposal to the South. Domestic wastes are burned, covered the ash with crushed run and compacted. Updates or revisions to the approved Operation and Maintenance Plans. ix. No update or revision to the O&M manuals was required during this reporting period since all the facilities remain unchanged.
