Hello Bhabesh,

yes you are correct in that most other communities have effluent quality limits in their licenses of 120/180 for BOD/TSS. This is evolving however with the use of wetlands and the need to continually improve to try to meet the requirements of the fisheries act and the non-acute toxicity. Having said that, the NWB has issued renewals recently that have incorporated both, the 120/180 and then limits at the end of the wetland of I believe 45/45. I do not know at the moment why the ARC licence was restricted to the 100/120 limits but I suspect it may have had something to do with the location of the discharge, time of year and/or intervenor comments that were received during the licensing process. This would take some time to review the file. Possibly Jim Wall has some insight to this as he may have been involved with the licence at the time.
