The NWB has completed its preliminary review of the following management plans and manual received February 4, 2015 in support of relevant requirements in Licence 3BM-ARAC1419, issued to the Hamlet of Arctic Bay.

- Solid Waste Operation and Maintenance Plan for Hamlet of Arctic Bay, January 2015; and
- Arctic Bay Truck-fill, Arctic Bay, NT, Operations and Maintenance Manual (Volume 1 of 2), June 1998

Solid Waste Operation and Maintenance Plan

The review determined that the Solid Waste OM Plan meets the Licence requirements and will be distributed for public review and comments.

Truck-fill Station, Operations and Maintenance Manual

The review determined that the Truckfill Station OM Manual in its current form does <u>NOT</u> meet the Licence requirement for public distribution. The NWB recommends that the Licensee provide a new manual based on relevant sections of the existing manual, while limiting the scope specifically to the truckfill station at Arctic Bay and addressing the following items:

- Information related to the Clyde River Truck Fill Station should be removed from the manual. As the Licence under which the manual is to be approved is specifically issued to the Hamlet of Arctic Bay, the scope of the manual <u>must</u> be limited to the potable water treatment facility at Arctic Bay.
- All unnecessary references made to the Northwest Territories should be excluded from the new manual.
- Information/design specifications included in the pre-design section of the manual that is not applicable to the facility should be updated or excluded from the new manual.
- The manual should address all aspects of the maintenance and operations of the Arctic Bay , potable water treatment facility.
