Dear Sheldon Dorey and Megan Lusty,

The Nunavut Water Board (NWB or Board) has completed the technical review of the 2022 Annual Report (Report) for Type "B" Water Licence 3BM-BAK1526 (Licence). The Report was received on March 30, 2023 from the Hamlet of Baker Lake (Hamlet or Licensee) and Government of Nunavut's Community and Government Services (GN-CGS) and submitted as a requirement under Part B of the Licence.

The technical review of 2022 Annual Report found that additional information is necessary to meet the following requirements of the Licence:

• Part F – Item 2

"The Licensee shall submit an addendum to the Manual within the next Annual Report for the undertaking to address the relevant comments and recommendations made by intervening parties including AANDC and EC during the review period for the plan."

The NWB has not received the updated Plan required by the above condition of the Licence. This was due on March 31, 2016. Please submit the updated "Operation and Maintenance Manual for the Water, Sewage and Solid Waste Facilities" required by **Part F – Item 2** of the Licence to ensure compliance.

• Part G – Item 2

"The Licensee shall submit an addendum to the Plan in Part G, Item 1, within the next Annual Report for the Undertaking, to address relevant comments and recommendations made by intervening parties including AANDC during the review period."

The NWB has not received the updated Plan required by the above condition of the Licence. This was due on March 31, 2016. Please submit the updated "Abandonment and Restoration Plan for the Water, Sewage and Solid Waste Facilities" required by Part G – Item 2 of the Licence to ensure compliance.

Apart from the above, the Licensee should note that the 2021 Annual Report for the Hamlet's Water Licensee appears to be outstanding; therefore, efforts should be made to submit this report if the Licensee has not done so already.
