Comments: Ice cover still on Water Supply Lake; smoke plume from municipal dump carried over Lake. Manual records not yet being kept at WTP area. Fuel tank at Water Intake Station should be inspected by a certified professional as a precaution due to its close proximity to the Lake.

- Operation of WTP was taken over by CGS from the Hamlet. Repair work was being undertaken on underground conveyance line; some flooding of the system occurred this year.
- Spill kits and spill contingency plan still lacking for chemical storage and handling.

Other: Lack of essential replacement parts/inventory for water supply and treatment system. Lack of backflow stop on fire-line system to treated water supply line (possible public health issue).

Comments: Lagoon is seeping into landfill; drainage carries effluent through metals dump and picks up leachates from both the metals dump and solid waste dump areas. Large amount of garbage in lagoon area and flow pathways; garbage carried out to open water.

Comments: Windblown garbage everywhere; fencing required. Lack of overall management at landfill and metals dumps areas. No signage observed or areas designated for segregation of wastes; no areas designated for hazardous wastes or liquid waste products, resulting in mixed waste streams at both dump sites. Spills present in metals dump from vehicles that have not been drained adequately before being discarded.

Licensee is advised to take measures to bring the situation at the solid waste site under control, and to implement measures that will encourage responsible disposal practices not only by Hamlet operators, but by private operators and contractors as well.

Comments: There is currently an unauthorized structure built a local contractor that was intended for this purpose (outside the Metals Dump). As the structure was not approved by the NWB or Hamlet, it must be removed before illegal dumping can occur here.

The community is in need of a properly constructed storage and/or disposal area for liquid and hazardous wastes and contaminated soils.

Licensee is strongly advised to take measures that will encourage better fuel handling and disposal practices by business operations on Commissioner's Lands.

Comments:

Kitnuna is responsible for the Hamlet fuel contract and manages two Tank farm sections and a refuelling station.

- Kitnuna currently has one tank in use which sits outside the Tank farm berm containment area.
- Tank at refuelling station requires maintenance of bermed area; labelling on tank and relevant signage requires updating.
- Spill kit/material storage was not identified in refuelling station area.
- Water collecting inside tank farm berms is discharged directly to the environment without confirmatory sampling.

Nunavut Power Corporation (NPC) operates a Tank farm (between the two Kitnuna sections), truck fill station and refuelling station adjacent to Kitnuna operations.

• NPC's truck fill station requires immediate attention and cleanup –the liner is poorly maintained and placement is inadequate for use; fuel staining present outside lined area.

Other: Fuel pump station at the float plane dock was left unlocked and unattended, with the refuelling nozzle and a full jerry can left on the dock. Fuel tanks in this area require maintenance.

It is highly recommended that the Owner ensures their contractor tests for BTEX and Oil and Grease (HEM) in water collected within the tank farms next spring, prior to discharge to the environment. This is confirmatory sampling to ensure compliance.

Licensee is advised to take measures that will encourage better fuel handling and storage practices by business operations on Commissioner's Lands.

Non-Compliance of Act or Licence:

The Licensee has not yet met the requirements set out in the April 2009 Water Licence Renewal or the commitments made in the renewal application –many of which are directly related to issues noted during the inspection.

- Lack of signage, monitoring and reporting requirements
- Lack of operations and maintenance manuals, spill prevention/contingency plans and related training
- Overall lack of solid waste management
