RE: NWB Technical Review of 2020 Annual Report for the Municipal Water Licence No: 3BM-CAM2030 issued to Hamlet of Cambridge Bay

Dear Ms. Limousin and Mr. Alam,

The Nunavut Water Board (NWB or Board) has completed a technical review of the 2020 Annual Report submission for the above stated Water Licence. On April 07, 2021, the Board acknowledged receipt of the 2020 Annual Report, and provided them to the Kitikmeot distribution list for information. No comments have been received to date.

The technical review of the Annual Report, found that additional information is necessary to meet the following requirements of the Licence:

▪ **Part D – Item 12**

*“The Licensee shall, **within twelve (12) months** of issuance of this Licence, submit to the Board for review, a study report, discussing options for reduction of metal concentrations within the Effluent at Monitoring Program Station CAM-6.”*

The NWB has not received the study report required by the above condition of the Licence. This was due on May 27, 2021, twelve (12) months from the date of issuance of the Licence. Please submit the Plan required by **Part D – Item 12** of the Licence to ensure compliance.

▪ **Part F – Item 2**

*“The Licensee shall, within the 2020 Annual Report, submit to the Board for review, a stand-alone **Water Supply Facility Operation and Maintenance (O&M) Manual** that addresses all comments received during the review of Application and includes a schedule for recording daily water use volumes requirements.”*

The NWB has not received the O&M Plan required by the above condition of the Licence. This was due on May 27, 2021, twelve (12) months from the date of issuance of the Licence. Please submit the Plan required by **Part F – Item 2** of the Licence and ensure it addresses the recommendations received during the application.

▪ **Part F – Item 3**

*“The Licensee, shall, **within ninety (90) days of issuance of this Licence**, submit to the Board for review, as-built report and drawings for the Water Supply Facility that are signed and stamped by an Engineer.”*

The NWB has not received the as-built drawings and report for the Water Supply Facility required by the above condition of the Licence. This was due on August 26, 2020. Please submit the documents required by **Part F – Item 3** of the Licence to ensure compliance.
