Re: Your Concerns regarding storage of material at the Cambridge Bay Metal waste facility in Cambridge Bay (letter addressed to Barry Wilson)

Point number 1 in your letter: Kitnuna has removed all drums we are responsible for from the Metal waste facility in Cambridge Bay. Please note that many of the drums you seen at the time of your inspection were not our responsibility. I realize you had no way of knowing this but I can assure you that the drums from Kitnuna were responsibly stacked and were left in an orderly condition. There are other users of that facility and we will not clean up a mess and spills caused by others.

The other requirement in item 1 is to provide copies of permits for transportation, storage, and incineration of hazardous waste. On this point I will ask you provide specific reference to compliance requirements. In regards to our operations we deliver bulk fuel to residences, businesses and facilities in Cambridge Bay. We have a licensed and approved tank farm facility in Cambridge Bay. In one of our buildings we have a waste oil furnace that burns used crank case oil. These are all in compliance with our routine activities in Cambridge Bay. Many of these activities are tied to specific Government Contracts, which do not specify particular permitting and licensing requirements. Please clarify the specifics you are seeking.

In regards to our activities at the Cambridge Bay Metal waste facility many of these products are in deed waste or off spec fuels generated by many sources in the community including Nunavut Power Corp, Arctic Airports, The Hamlet of Cambridge Bay and of course Kitnuna Construction Ltd. It is by mutual agreement over the years that we work together minimize the accumulation of waste oils and contaminated or off specification fuels. I would like to work with in the required permitting and in full compliance of all requirements. I will evaluate our participation in this mutual agreement structure if it proves to be cumbersome.

Deposit of Waste in Contravention of Water Licence NWB3C AM0207**- Inspector's Direction -**

I, Constantine Bodykevich, duly designated Inspector pursuant to subsection 65 (1) *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, conducted, on September 4, 2003 an inspection of Cambridge Bay metal dump.

As stipulated in subsection 12 (1) Except in accordance with the conditions of a licence, no person shall deposit or permit the deposit of waste in any other place under conditions in which the waste, may enter waters in Nunavut.

As stipulated in subsection 12 (3) Where waste is deposited in contravention of this section, every person who owns or has the charge, management or control of the waste, or who caused or contributed to the deposit, shall, subject to the regulations, without delay report the deposit to an inspector.

At the time of the drafting of this letter Kitnuna Corporation was in contravention of subsection 12 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*.

On September 4, 2003 Barry Wilson Vice President of Kitnuna Corporation Box 92 Cambridge Bay was directed to:

1. Remove all waste oil, waste fuel and associated drums that have been placed in the Municipal metal dump by the Kitnuna Corporation and or its agents. Have full drums of fuel properly sealed with all bungs in place. Place and label fuel in proper storage area.


As such, under the authority vested in me pursuant to subsection 87 (1) (ii) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, I hereby direct, Barry Wilson and Kitnuna Corporation to immediately take all reasonable measures to prevent further unauthorized deposits of fuel, waste oil and associated products from entering the Cambridge Bay Solid Waste Facilities. No hazardous waste shall be transferred to or from Kitnuna Corporation property without the possession of an Hazardous Waste Transportation permit and where required a Hazardous Waste Storage permit.

- ☐ Immediately remove any 45 gallon drums of waste oil, waste fuel or other waste that has been deposited at the Cambridge Bay metal dump by Kitnuna Corporation employees or subcontractors.
- ☐ Immediately send all permits pertaining to the transportation, storage and treatment of hazardous waste held by Kitnuna Corporation as they apply to the transportation, storage and incineration of hazardous waste.

Failure to comply fully or in part with an Inspector's Direction constitutes a offence under subsection 90 (1) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* and entails, upon summary conviction, a fine of \$100,000 or to imprisonment for a term of one year, or both. Further pursuant to subsection 90 (4) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, each day on which the Inspector's Direction is not complied with shall be considered a separate offence.
