Hi, Bill,

The scope is not too onerous, but will take time, and you will need the help of the NWB and CGS. However, we are hoping that the two engineering firms that are already involved with the systems in Cam Bay will be able to pull this together, at least to help you complete the application. So:

Water System: This should be basically in compliance, but will need some reports, etc generated. We will help by providing you with the most up-to-date drawings and schematics we currently have of the WTP and the rest of the water system, as up-graded. Right now the O&M manual is virtually non-existent, and we are working to acquire more funding to finish this aspect of the work on the water system through our consultants, Dillon. If we are successful, we can ask Dillon to work with us to get this aspect of the license completed.

Sewage, etc: As you know, this is all in process of being upgraded, and is in the final design phase. There will have to be O&M manuals, perhaps quality assurance plans, abandonment and restoration plans for the sewage and perhaps the MSW sites. As for the latter, Earthtech will be doing these as a matter of course for its contract with us. The fact that these are in process as part of the new upgrades shows due diligence, and the NWB should be OK with that.

No promises, but we are hopeful that this will work out so you do not have to hire any other engineering firm. I am copying this to INAC and to the NWB in a separate e-mail for further comment. If I get any other info, I'll let you know.
