I note the following excerpt from the water license. Please advise if this is the construction work that Ryan describes below.

"The scope of the renewal application includes 1) ongoing operation of the existing Sewage Disposal Facility and Solid Waste Disposal Facility, and 2) the redesigning and enhancement of the current Sewage Disposal Facilities and Solid Waste Disposal Facility and the construction of a Sewage Wetland leading to an outfall east of the current outfall. The proposed redevelopment of the Sewage Disposal Facilities would involve the construction of berms to divert run-off around the facilities. The Sewage Disposal Facilities would also be enhanced through the construction of a two cells that will increase hydraulic retention time and increase the capacity of the facilities. The redesigned facilities would move the discharge of the lagoons further east, away from the community and through a constructed wetland."
