Re: OTT-00209248-A0 – Abandonment Restoration Plans – Hamlet of Cape Dorset

Dear Ms. Beaulieu:

Further to the plan for compliance for the water licence 3BM-CAP0810 (expired) for the Hamlet of Cape Dorset (Hamlet), Please accept the letter as clarification to licence condition G-2 which reads as follows:

The Licensee shall submit to the Board, for approval in writing, within six (6) months of issuance of this Licence, a preliminary or conceptual Abandonment and Restoration Plan for the Hamlet of Cape Dorset, Water and Waste Disposal Facilities and all associated structures not covered under Part G, Item 1, with end objectives to return the site to pre-use conditions.

As part of the community site visit undertaken by **exp** Services Inc. (**exp**) during the winter of 2012 / 2013 and discussions with the Hamlet as part of that site visit, it is determined that the Hamlet has not taken over the new sewage lagoon, referred to as the 2007 sewage lagoon, due to issues with this facility. Therefore, the Hamlet has no intention of abandoning the existing wastewater facilities. Additionally, the Hamlet has no intentions of abandoning the existing domestic waste or bulky metal waste sites and as such abandonment restoration plans are not required at this time.
