The Nunavut Water Board acknowledges receipt on April 23, 2001 of your application form as part of the application previously submitted. At this point, the application is only **missing** the following item, as stated in the April 19th letter:

- short summary/paragraph of the application in English AND Inuktitut

This project is exempt from screening by the Nunavut Impact Review Board according to Schedule 12-1 of the Nunavut Land Claims Agreement and is ready for processing by the Nunavut Water Board.

I have been asked by the Board to inform you that a <u>notice of your application is required</u>. This notice of requirement is based on Article 13.3.14 of the Nunavut Land Claims Agreement (NLCA), which states that the Board should take "...all steps necessary by way of notice...to provide and promote public awareness [of hearings]."

Accordingly, please have the enclosed notice in both English and Inuktitut published in a two-column width format in the **Nunatsiaq News** as per enclosed "Instructions for Publication of Notice in Newspaper." The Applicant is responsible for payment of the publication.

Upon request from the public, we ask you to make available, free of charge, copies of all documents pertaining to this application. Any person who is affected by this application or concerned with it, may submit a letter of concern, which must be submitted to the Board within the period of time shown on the public notice.

Please note that the confirmation of notice posting, must be submitted to our office before your application process will be completed.
