Hi Ralph,

Sorry for the mix up with the previous email (RE: Review of the Taloyoak state of Compliance). Below is my review of your progress with the Cape Dorset Water License 3BM-CAP0810 and compliance with the Compliance Plan.

Again, for Cape Dorset, many of these conditions were assumed fulfilled after the GN's last submission of documents on March 14, 2014; however, many of the documents were not up to the standard required by the Inspector in order to fulfill the outstanding conditions of the licence. And in many instances, **no work** has been completed to even address the issue, even after the Original due date and the due date as per the Compliance Plan. Furthermore, many of the issues of non-compliance can be solved through simple administrative work and there is no excuse for delay.

Ralph, I am requesting you address each and every issue of non-compliance in this email, and explain exactly where you are in the process. Have your comments to me by April 14, 2014.
