This letter is in response to the letters and attachment issued by the Nunavut Water Board (NWB) dated July 17, 2007 and August 08, 2007. The three major work items that precipitated from the meeting on July 17, 2007 that the proponent is to address, are the followings:

1. The completion of the geotechnical assessment of the as-constructed conditions. This assessment is to include, but will not be limited to;
 - a. Stability of the berms
 - b. Thermal analysis of the system over the life of the facility (20 years)
 - c. Seepage analysis
 - d. Design criteria

2. The record drawings and O&M manual:

These will be submitted 90 days from the date of issuing License to comply with NWB regulations.

3. Responses to several remaining items from July 11, 2007 meeting:
