Anjan,

As per our telephone discussion May 24th, 2006 (approximately 25 minutes) I had committed to inquiring about the need to provide a full detailed Operations and Maintenance Manual for the Sewage Lagoon Amendment in Cape Dorset (prior to licence issuance) due to the project specifics outlined by you. The NWB has decided that the Hamlet is to provide a detailed scope of the O+M to be submitted with this scope accompanying the an anticipated response to the NWB letter addressed to the Hamlet of Cape Dorset on May 8th, 2006. This detailed scope is to be submitted prior to issuance. As discussed in our telephone call this detailed scope is to include sufficient detail in what will be contained in the O+M Manual, a proposed table of contents, and a commitment date for anticipated submission. I would like to reiterate once again that this should not be a loose outline but a fixed, methodic, and thorough outline. As also discussed in our conversation the O+M Manual could influence the containment capabilities of the facility and the level of treatment.

As per the NWB's request for a declaration of authorization for other parties the Hamlet of Cape Dorset has authorized Dillon Consulting to act on their behalf. I have included Dillon Consulting on this correspondence as they are authorized. I would suggest that if the GN is planning on communicating with the NWB in the future on the Hamlet's behalf that they have formal permission to do so. In the declaration of authorization from the Hamlet of Cape Dorset there is no indication that the GN is to discuss on their behalf. The NWB requests that the Hamlet authorizes the GN to communicate on their behalf and agrees to the arrangement communicated on May 24th, 2006. As stated the Hamlet is the Licensee and is bound to the conditions of the licence. They must authorize such communication. This needs to be completed immediately.

The NWB does understand that time is of essence. Through proactive correspondence on file status, the NWB also understands that the final design prepared by Dillon Consulting was completed and submitted to the GN in November of 2005. The NWB did not receive a formal application submission until February 13th, 2006.
