Subject: Plan for Compliance for Water Licence 3BM-CLY0909

Dear Mr. Roy and Mr. Buckle,

The Nunavut Water Board (NWB or Board) received an application for renewal of Water Licence 3BM-CLY0909 (Licence) from the Government of Nunavut Community Government Services (GN-CGS) on behalf of the Hamlet of Clyde River dated October 27, 2009 (Renewal Application). The Renewal Application included a Plan for Compliance in accordance with Part B Item 12 of the Licence.

In conducting its internal preliminary technical review the NWB found a number of deficiencies with the Plan for Compliance and noted that the Plan was required to be submitted to the Board for approval by April 18, 2009. Because the Plan was submitted as part of the Renewal Application and given the importance of the Plan to the renewal process, the Board determined that deficiencies in the Plan must be addressed before the Renewal Application could be determined to be complete.

On November 27, 2009 the NWB provided the results of its internal preliminary technical review to the GN-CGS and the Hamlet advising the following:

"The Board will not proceed with processing the Renewal Application until a satisfactory response to the above issues [deficiencies in the Plan for Compliance] is provided by the Licensee". <sup>1</sup>

A response from GN-CGS was received by the NWB on December 9, 2009. The October 27 and December 9, 2009 Plan for Compliance submissions include the following:
