Good morning Bhabesh,

Thank you for resubmitted application and associated documents. For your information: A preliminary quick information completeness check will be completed internally before sending the application package for 30 public review.

I understand that a lot of work went into preparing the application package, however based on my quick look at the Plan for Compliance I noticed that the status for some Items indicated as In compliance couldn't actually be the case. The Items F1, F2, F6, F8 are actually in Non Compliance presently, as those Plans weren't approved by the Board.

**Documents submitted along with the Plan for Compliance for approval. In this case, as an applicant it is wise to say "in compliance".**

I have also a couple of questions:

1. July 2012 O&M Plan for Waste-water Facility states that currently the sewage lagoon is a 2 cell lagoon. Your Technical Summary of Environment Projects states that Community has been using both lagoons since they were commissioned in 2011 as the old lagoon was rehabilitated.

The questions are:

The 2 cell lagoon system stated in the O&M Plan are the old and new lagoons parallel?

The new lagoon was built using a common berm of the existing old lagoon. Both can function independently in parallel.

How the old lagoon was rehabilitated, any sludge removed? No details are provided with this respect.

No, Sludge was not removed out of the old lagoon. Sludge was stockpiled at one end, liner was placed in that area first and then sludge moved back, complete the liner and finally sludge was placed on the top of the liner with uniform thickness.

Weather or not a Geotechnical Inspection was conducted with the commissioning of the New Lagoon? If yes, could you include also the Inspection Report?

**Yes, The consultant did a full time supervision of the construction and issued a completion certificate. During operation /commissioning, no geotechnical inspection was done by a geotechnical Engineer yet. I did last summer. This is a brand new facility, working perfectly.**

AN O&M Manual for Clyde River Truckfill dated 1998 prepared for GNWT is included within the application.

Although it may be possible that no changes happened with the community water distribution system, however, the Plan should be updated in the future to reflect the current situation.

**Yes, I will do in future next time renewal phase.**
