## 1. Cape Dorset existing license renewal

- a. Confirm if admin fee was paid
- b. Require 3 page application form signed by SAO of Hamlet
- c. Provide summary report in English and Inuktitut
- d. Assessment of Compliance to be carried out by NWB and provide with application information for review and comment by parties??? (monitoring, annual reports, OM Manual)

#### 2. Kimmirut

- a. License expired in August 2007
- b. Confirm if admin fee paid for renewal
- c. Require 3 page application form signed by SAO of Hamlet
- d. Current licence includes the lagoon facility (see email Dionne to Bhabesh, May 31, 2007) but does not address the current method of disposal. Apply for renewal only (exclude new facility), amendment to come later
- e. Geotechnical assessment required
- f. Confirm Fisheries Act compliance
- g. Provide summary report on facilities, English and Inuktitut
- h. Assessment of Compliance to be carried out by NWB and provide with application information for review and comment by parties??? (monitoring, annual reports, OM Manual)

### 3. Resolute Bay

- a. License to be issued to CGS for water and sewage
- b. License to be issued to Hamlet for solid waste
- c. License application on file is for the Utilidor (and water?)
- d. Require application form from the Hamlet for the solid waste, signed by SAO
- e. Make list of documents received to date and send to Bhabesh Roy to confirm what documents are and for what application
- f. Send license for utilidor out for review and comments as soon as confirmation received on what documents apply to this application

g. Jim and Dave to review documents and confirm ready for distribution

# 4. Arctic Bay

- a. Current Licence expires October 31, 2007
- b. Current Licence refers to an "Engineered Mechanical System" in the definitions
- c. Old lagoon is under capacity
- d. Require 3 page application signed by SAO
- e. Stream diversion needs to be part of application
- f. Amendment to be submitted after renewal is issued (Wetlands assessment, treatment capacity with hydraulic, organic loadings)
- g. DFO authorization or confirmation that not fish bearing
- h. Decommissioning of old lagoon

## 5. Clyde River

- a. Apply for renewal with terms and conditions same as the current license
- b. Require 3 page application signed by SAO
- c. Any amendment is to be submitted after the renewal is issued
- d. Wetlands assessment, treatment capacity (hydraulic, organic loadings)
- e. Compliance point (last point of control)
