### Good day Bhabesh,

Further to the email below and a followup email that I placed to Kevin Buck with INAC, (and your followup inquiry with the NWB Licensing as to the issuance of the Clyde River renewal licence) I would like to suggest a potential teleconference sometime next week with interested parties (NWB, GN and consultant, INAC, EC, GN DoE etc) on the conditions of the Clyde River amendment and forthcoming renewal as well as the Kimmirut Licence recently issued and reviewed by TROW for the GN.

There are several issue that need to be discussed, including:

- Compliance with the Clyde River amendment issued in September 2008, administrative issues regarding the submission of a Plan for Compliance and QAQC Plan to the Analyst for approval and inclusion in the Operations and Maintenance Manual. The Licence expiry date was extend to March 15, 2009 to accommodate construction and submission of a number of Plans prior to renewal;
- 2) Construction issues for both Clyde River and Kimmirut and compliance during construction; TROW identified several issues with the Kimmirut Licence that apparently will not be possible due to construction, and the NWB is concerned that these issues are possibly similar to the Clyde River construction. With respect to the Kimmirut Licence, the NWB incorporated conditions from the previous licence and was unaware of the facts brought forward by the Consultant in way of construction and not being able to use the facility during that time (was there a plan for collection and treatment of the sewage during this time that the NWB did not take into consideration or was unaware of?); and
- 3) Any other items that may have become apparent following submission of both the reviews of the Clyde River and Kimmirut Licence conditions.

If there are any other items that need to be discussed at this time it would be appreciated if the NWB could be made aware of prior to setting a time and date for a teleconference. Some of these may include upcoming renewal/amendment applications that have recently been submitted to the NWB and similar issues.

If there are documents or email correspondence that you require, please contact Phyllis or Richard with Licensing. The majority of this information should be available under the respective licence folders on the ftp site.

#### Bhabesh,

Thank you for your email (and attachments) in follow-up to our telephone conversation on Thursday January 29, 2009, regarding the Clyde River renewal application and outstanding issues from the amendment that was issued on September 26, 2008.

The letter you have included was indeed received by our licensing department on January 8, 2009 (the letter version addressed to Phyllis Beaulieu) however, it does not address the issue that was discussed. The letter of January 8<sup>th</sup> was further distributed to Environment Canada for review and a request for expert advice on the effluent quality limits, the use of the wetland and the application of toxicity testing of the municipal wastewater effluent. These comments have been accepted as part of EC's submission and have been considered in the current renewal review process.

With regard to my inquiry, the outstanding issue that was discussed falls under Part B, Item 10 of the Amendment issued in September. The NWB Licensing Manager confirmed

that a "Plan for Compliance" has not been received by the NWB. This omission was also noted in INAC's submission of January 2, 2009, Item C, under Comments and Recommendations.

I will follow-up this email with a letter to address the outstanding Plan and provide options for submission. Please advise if the Plan was submitted as earlier indicated and that possibly it had not been received by the Licensing department. I will confirm this omission with Phyllis along with any other requirements of the amendment that may be outstanding and include in the future correspondence.
