Tom:

Seeing that you're away this week, perhaps we can address this by email. Here below are the files and status as I know them, which I was looking to inquire about. You can simply fill in any information you have below each one. We are particularly interested in when a submission can be expected for each.

Clyde River (3BM-CLY0909):

The Plan for Compliance for Clyde River, which is requirement of the licence renewal process for this file, was rejected by the Board on March 18 of this year. The Board requested that a revised Plan be submitted.

How is this coming along?

Arctic Bay (3BM-ARC0810):

The renewal application was acknowledged by the Board on June 24, 2010. A Plan for Compliance was a requirement of the renewal application, but it was found to be insufficient. The Board requested that a revised Plan be submitted.

How is this coming along?

Cape Dorset (3BM-CAP0810):

A renewal application was received by the NWB on March 3, 2010. On June 23, 2010 the NWB requested a comprehensive Plan for Compliance and a revised Operations and Maintenance Manual before processing the renewal application.

With respect to the Plans for Compliance the NWB also issued a draft template to CGS to assist with the preparation of those Plans. However, I'm not sure that it's being used based on what was submitted by Mr Roy most recently for the Sanikiluaq file. I've attached the draft template for ease of reference.

If you could provide an update on the above files and any others that you may be working on it would be greatly appreciated.
