Subject: Water Licence 3BM-CLY0909 – Plan for Compliance

Dear Mr. Roy,

The Nunavut Water Board (NWB or Board) acknowledges the receipt on February 15, 2011, of a Licence submission package for the above noted Licence, that included the document entitled "<u>Plan for Compliance Licence No: NWB 3CLY0308</u>, <u>Municipality of Clyde River</u>" (2011 Plan for Compliance), submitted by the Government of Nunavut Community Government Services (GN-CGS) on behalf of the Hamlet of Clyde River (Licensee), in accordance with Part B, Item 12 of the Licence and in response to the Board's March 18, 2010 decision regarding the Plan for Compliance and Application for Renewal of Water Licence 3BM-CLY0909.

In conducting a preliminary review of the submitted 2011 Plan for Compliance, the Board notes that the Plan had been prepared for an inactive water licence, <u>Licence No. 3BM-CLY0308</u>, which was renewed and superseded by water licence <u>3BM-CLY0909</u> on March 19, 2009. Although water licence 3BM-CLY0909 expired on November 13, 2009, it remains the active licence for which the Licensee is obligated to comply with, in accordance with section 46 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*.

As such, the Board is requesting the submission of a revised Plan for Compliance, based on the terms and conditions of water licence 3BM-CLY0909 as well as the deficiencies identified in the Board's March 18, 2010 decision, for the written approval of the Board. A copy of water licence 3BM-CLY0909 and the Board's March 18, 2010 decision are attached to this letter for your reference. The GN-CGS and the Licensee are reminded that the revised Plan must be submitted for, and approved by the Board prior to the Board accepting and processing the Licensee's water licence renewal application, received on November 27, 2009.
