subject to screening by the Nunavut Impact Review Board. In particular, please note that as established under Articles 11, 12 and 13 of the Nunavut Agreement, NuPPAA and Part 3 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, until the project has completed the applicable land use planning and assessment process required by the NPC and the NIRB, the NWB cannot issue a water licence/approval.

The NWB confirms receipt of NPC conformity under NuPPAA on April 16, 2021 and NIRB determination through NPC under NuPPAA on April 16, 2021. This application is now ready for review and comments. Deadline for submissions is **July 29, 2021**.
