The Nunavut Water Board acknowledges receipt on February 5, 2003 of your water licence application, filed on your behalf by Ferguson Simek Clark, for the Municipality of Grise Fiord. The application included the following items:

- application form
- supplementary questionnaire
- executive summary in English and Inuktitut
- Section 2 - information for the water license application
- Appendix 1 - maps and drawings
- Appendix 2 – Hazardous Materials Spill Reports
- Appendix 3 – INAC Inspection Reports
- Proposal for Engineering & Architectural Services, Water Supply Improvements, FSC report dated January 28, 2000

By copy of this letter to Ferguson Simek Clark we formally request the \$30.00 application fee in cheque form made payable to “Receiver General for Canada”. This will complete the requirements of the application.

This project is exempt from screening by the Nunavut Planning Commission and by the Nunavut Impact Review Board due to its municipal status.

I have been asked by the Board to inform you that a notice of your application is required. This notice of requirement is based on Article 13.3.14 of the Nunavut Land Claims Agreement (NLCA), which states that the Board should take “...all steps necessary by way of notice...to provide and promote public awareness [of hearings].”

Accordingly, a notice in both English and Inuktitut will be posted for a period of 30 days, with local establishments in Grise Fiord.
