Re: Additional Information Required: Information Request # 1 for Government of Nunavut – Community & Government Services’ “Amendment to Municipality of Grise Fiord Water License 3BM-GRI2025” Project Proposal

Dear Community Support Division,

On March 1, 2024, the Nunavut Impact Review Board (NIRB or Board) received a referral to screen Government of Nunavut – Community & Government Services’ (GN-CGS) “Amendment to Municipality of Grise Fiord Water License 3BM-GRI2025” project proposal from the Nunavut Planning Commission (Commission), with an accompanying positive conformity determination with the North Baffin Regional Land Use Plan.

Pursuant to Article 12, Sections 12.4.1 and 12.4.4 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement)* and s. 87 of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (*NuPPAA*), the NIRB has commenced screening this project proposal. Due to the proposal containing activities that are sufficiently related to previously assessed activities under NIRB file number **23XN069**, the NIRB views this project proposal as an amendment to the previously screened project and has assigned this proposal with this previous file number. Please reference this file number in all future related correspondence.

On March 4, 2024, the NIRB requested that the Proponent complete the online application form through the NIRB’s public registry system and ensure, pursuant to s. 144(1) of the *NuPPAA*, that sufficient information is provided to determine the scope of the project activities being proposed and to commence screening.

To date, the NIRB has not received your project proposal and request that the information be submitted in order for the NIRB to carry out its screening. According to s. 144(1) of the *NuPPAA*,

the NIRB is requesting submission of the information as outlined in Appendix A of this correspondence by **April 18, 2024**.

The documents and materials received to date by the NIRB in support of this project proposal include:

- *Commission Conformity Determination*
- *Commission Application*
- *2020 Water License*
- *Proponent Email to Commission*

Please be advised that pursuant to s. 92(3)(b) of the *NuPPAA*, the 45-day timeline for the Board to provide a screening decision stopped on April 4, 2024. This 45-day timeline will start again on the date the NIRB receives the requested additional information. If the Proponent fails to submit the requested additional information, the Board may suspend or terminate the assessment activities of the proposed project pursuant to the relevant provisions under s. 144 of the *NuPPAA*. Therefore, it is in GN-CGS's best interest to cure the identified information deficiencies in a timely manner. If GN-CGS determines that the time required to supply the required information is significantly greater than two (2) weeks, the Board requests written notification and an anticipated date for submission be provided as soon as possible.

Additionally, please be aware that the NIRB and the Nunavut Water Board (NWB) are required to coordinate their processes¹ for projects that require a water licence, especially municipal undertakings in order ensure the timely review and processing of the application. In undertaking a coordinated NIRB-NWB process, the Proponent must provide information through the assessment to satisfy both the impact assessment requirements as well as the water licensing process; furthermore, where information to satisfy each process is similar, coordination of the timing or contents of applications may be considered when information is being submitted to both organizations. However, the Proponent has the option to request or opt out of a coordinated process at any time. Should you wish to opt out during the initial submission of this application or discontinue the coordinated process, you may do so in writing to both the NIRB and the NWB.

1. TOPIC/ISSUE: NIRB’s Online Application Form

REFERENCE: *Proponent’s Guide*²: Appendix A: Online Application System – Proponent User’s Guide

RATIONALE: The NIRB requires the Proponent to complete the online application form in order to determine the scope of the project activities being proposed and to ensure sufficient information has been provided to commence screening. The NIRB will no longer accept applications or supporting documents via e-mail or regular mail.

REQUEST: Complete the NIRB’s online application form at www.nirb.ca, pursuant to the NIRB’s project application requirements.

The Proponent is recommended to review the Help Boxes associated with the NIRB’s online application form when completing the application.

2. TOPIC/ISSUE: Project Map

REFERENCE: *Proponent’s Guide*²: Appendix A: Online Application System – Proponent User’s Guide

RATIONALE: The NIRB requires a map of the project proposal and related activities to assist in the assessment of the project.

REQUEST: Complete the NIRB’s online map in the application form at www.nirb.ca as well as provide the latitude and longitude of the locations as listed within the application form. The map should include where applicable the following items:

- Location(s) of any existing or proposed infrastructure(s) including but not limited to:
 - a. Camp location(s) (temporary and/or permanent) and camp facilities,
 - b. Road(s),
- Location(s) of all proposed activity(ies) including but not limited to:
 - a. Fuel storage sites,
 - b. Use of vessel equipment;

3. TOPIC/ISSUE: Non-technical Project Proposal Summary in English, and Inuktitut

REFERENCE: *Proponent’s Guide*²: Appendix A: Online Application System – Proponent User’s Guide

RATIONALE: The NIRB requires that a non-technical summary be submitted by proponents in order to assist parties to understand and provide comments on project proposals. Translated copies of the non-technical summaries are required to be inserted into the text boxes provided in order to assist unilingual community organizations and members to provide comments on project proposals.

REQUEST: Submit via the online application text boxes a non-technical description of the project proposal in English and in the regional languages, which include Inuktitut (Kivalliq, North/South Baffin, Eastern Kitikmeot).

The summary should use plain language only and address the following points in < 5,000 characters:

- **Who:** Company, individual or entity proposing the project.
- **What:** The type of undertaking being proposed and how it would be carried out. It may be helpful to describe the scale of the project, number of people involved, permanence of any facilities constructed, and methods of transport.
- **Why:** The objective of and need for the project, potential long-term implications.
- **Where:** general location of proposed activities in relation to closest communities, protected areas.
- **When:** timeframe of proposed activities (fixed period, seasonal, multi-year).

Please keep in mind that the project summary is intended to provide members of the public with sufficient information to understand what is being proposed and determine whether they might wish to further review the full project application and supporting information.
