Good Evening Bhabesh,

The NWB has reviewed the application submitted by the GN for a new water licence for the solid waste and soil material previously excavated as part of the Hall Beach Sewage Disposal Facility work approved by the NWB in 2015. We understand the following from the application material:

- Approximately 4000 m³ of solid waste and soil was excavated from the area of the Sewage Disposal Facility works and stockpiled on a temporary basis within bermed areas adjacent to the existing Hall Beach Solid Waste Facility.
- Sampling was carried out in 2017 to evaluate soil and water quality within the bermed area.
- The GN is requesting a new licence for the temporary storage, monitoring, segregation and transfer of the waste to the existing Hall Beach Solid Waste Facility, and reclamation of the temporary storage areas will then be completed.

In carrying out its initial review of the application, the NWB also reviewed the existing municipal water licence 3BM-HAL1520 and Amendment #1 to that licence issued on July 17, 2015. The latter of which covered the expansion and rehabilitation of the Sewage Disposal Facility. The amendment application at that time noted “Garbage will be removed from the proposed footprint and disposed of in the solid waste site”, however this doesn’t appear to have been followed. The NWB also notes that the existing municipal water licence 3BM-HAL1520 contains an approved Solid Waste Facility O&M Manual:

"The review conducted for the plan entitled Hamlet of Hall Beach, NU, Solid Wates Facility Operation and Maintenance Manual, dated June 2011, determined that the Plan is acceptable and functional. The plan has been approved by NWB under Part F, Item 2 in the licence. The Licensee is required to update the plan on an annual basis to reflect any changes in operations or other factors that may impact the functionality of the plan". (3BM-HAL1520 at page 7).

Considering the above, and essentially that the temporary waste storage is directly linked to the undertakings conditioned under the existing municipal licence, the NWB advises that the GN withdraw the new water licence application and instead submit an updated Solid Wastes Facility Operation and Maintenance Manual in accordance with 3BM-HAL1520 to incorporate the plans to monitor, segregate, transfer and remediate the temporarily stored waste. In updating the plan the GN should provide the sample results of the 2017 work to confirm that it is appropriate to transfer the material, provide a schedule for completing the work, and indicate how it plans to manage contact water collected within the temporary berms.

Upon receipt of the updated plan, the NWB will circulate the information for review and comment in a timely manner.
