The Nunavut Water Board acknowledges receipt on January 9, 2003 of your water licence application for the Hamlet of Hall Beach. This application was prepared by Ferguson Simek Clark, on your behalf. Your application included the following items:

- executive summary in English AND Inuktitut
- application form
- supplementary questionnaire
- Information for the water license application
- Appendix 1 maps and drawings
- Appendix 2 Hazardous Materials Spill Reports
- Appendix 3 DIAND Inspection Reports
- Hall Beach Sewage Lagoon report prepared by FSC dated March 2002
- Specs for Sewage Lagoon Improvements prepared by FSC dated July 2002

Your application fee of \$30.00 has not been received to date and it is our understanding that FSC will be forwarding it shortly.

This project is exempt from review by NPC and the Nunavut Impact Review Board due to its municipal status. It can be processed by the Nunavut Water Board once the deadline for review and comments has been realized.

I have been asked by the Board to inform you that a <u>notice of your application is required</u>. This notice of requirement is based on Article 13.3.14 of the Nunavut Land Claims Agreement (NLCA), which states that the Board should take "...all steps necessary by way of notice...to provide and promote public awareness [of hearings]."
