# RE: NPC File # 149230 [Renewal and Amendment of the Hamlet of Hall Beach Water Licence # 3BM-HALL 1520: Type-B for 5 yrs. term]

The following works and activities have been proposed in the above-noted project proposal:

- 1. Renewal of a <u>Type B Water License # 3BM-HAL 1520</u> which is coming to expiration. This renewal will also accommodate the Hamlet of Hall Beach upcoming updates of municipal infrastructures such as the drinking water supply facilities, the sewage and the solid waste disposal sites.
- 2. Related NIRB File No.: EX243
- 3. Location: Qikiqtani Region [Hall Beach].

The Nunavut Planning Commission (NPC) has completed its review of the above noted project proposal. NPC has determined that this project proposal is outside the area of an applicable regional land use plan. The activities associated with this proposal were previously reviewed by NPC, and a conformity determination was issued on October 24, 2006, March 26, 2015, and on June 9, 2015 which still applies. This project proposal is exempt from the *Nunavut Planning and Project Assessment Act* (NUPPAA) under section 235 of that Act. The project proposal is exempt from screening by the Nunavut Impact Review Board (NIRB). The project proposal does not require screening because it belongs to a class of works or activities set out in Schedule 12-1 of the Nunavut Agreement, and the NPC does not have concerns regarding the cumulative impacts of the project proposal.
