Hi David,

To follow up on our conversation regarding Municipal water licensing, I've attached as you requested, the 5 compliance plans submitted by the communities and CGS. The plans were required by the Direction in order to demonstrate how the communities intended on coming into compliance with their water license. By submitting the plans, the communities have met this requirement of the Direction. The plans, as submitted, have been accepted by AANDC as they will ensure the communities achieve compliance if followed. As with all Directions, we are now actively working with CGS and the communities to ensure that the commitments made in the plans are completed. Please note the compliance plans are for reference only, they are in the process of being updated to reflect the progress made by communities during this summer field season. As discussed, a significant amount of time and effort has been invested by CGS and the communities to achieve compliance. The communities under Direction are well on their way to achieving compliance however some big ticket items such as new sewage lagoons will take some time to complete. In our view this should not prevent communities from getting a water license as a valid water license is also a requirement of the Direction. I've also included the letter I sent to Damien in September conveying our concerns that the water licensing process was suspended because of the Directions issued to the 5 communities.
