A summary of modifications and/or major maintenance work carried out on the Water Supply and Waste Disposal Facilities, including all associated structures and facilities; The Cell 1 lagoon has been expanded and made containment structure to function independently. The cell 2 still remains in exfiltration nature. A list of unauthorized discharges and summary of follow-up action taken; v. The cell-2 exfiltrates through the berms to the wetland. The effluent gets further treated in multiple ponds located in the wetland prior to reaching the receiving body about 3km away. vi. A summary of any abandonment and restoration work completed during the year and an outline of any work anticipated for the next year; No abandonment and restoration work was conducted during this reporting year. The existing solid waste sites were decommissioned and abandoned once the new facility is built and commissioned. vii. A summary of any studies requested by the Board that relate to waste disposal, water use or reclamation, and a brief description of any future studies planned; The planning for the better waste management in the Community is in progress. Any other details on water use or waste disposal requested by the Board by viii. November 1st of the year being reported; and The existing waste management is a big concern. Right now Hamlet is segregating wastes in proper manner. Batteries are being stocked in the sea scan. The waste management project is still on hold. The new guidelines will be implemented once design work starts. ix. Updates or revisions to the approved Operation and Maintenance Plans. The O&M manuals of the water supply system and non-engineered waste management and wastewater treatment facilities were already submitted to NWB. No update or revision of the O&M is required for waste management site at this stage. However, New O&M manual will be prepared once the construction of the sewage
