Executive Summary

Hall Beach Old Sewage Lagoon Restoration Project.

The old sewage lagoon was taken out of service in 2004 when construction of the new sewage lagoon was completed.

Samples from the old sewage lagoon show the water meets CCME standards for the protection of aquatic life and can be discharged directly to the ocean.

The sludge meets the draft guidelines for Abandonment and Restoration of Lagoons in Nunavut.

The project involves discharging the water from the old lagoon, blending sludge into soil, filling in low spots with new granular material, and positively grading the site so that water flows to the ocean. Old groundwater monitoring wells will also be removed.

The old lagoon site is beside the new lagoon. The land use category will not change.

The planning study has been reviewed by all stakeholders.

The project is scheduled to be completed by September 2006.
