Re: Additional Information Required for the Decommissioning of the Sewage Lagoon in Hall Beach, licence number NWB3HAL0308, Part G, Item 1

Dear Ron:

FSC, on behalf of the Hamlet of Hall Beach, has submitted the *Hall Beach Sewage Lagoon Decommissioning* report prepared by Trow, as required under Part G, Item 1 of the Hamlet's water licence. After reviewing the plan and correspondence on the file the NWB requires the following information is required before proceeding with the approval:

- Authorization from the Hamlet that FSC and/or the Government of Nunavut can communicate on their behalf for the decommissioning of the sewage lagoon;
- The sludge sample results, referenced in the Trow report; and
- The construction drawings and specifications for the decommissioning of the sewage lagoon, stamped by an Engineer.

The reason the NWB is asking for the sewage sludge sample results is because they are referenced in the Trow report and were used to determine the method for decommissioning the lagoon. The sludge sample results are also required to determine if the sludge is a "waste" according to the definition in the Hamlet water licence. If the sludge is "waste" then the Hamlet would be required to submit to the Board for approval design drawings stamped by a qualified engineer as required by Part E, Item 1 of the licence.

Also the Trow plan states that the sludge will be covered by 1.5 m of granular material but in your email June 19, you said that the sludge would be blended with the granular material and not left in single strata. Please submit any other changes to the plan with the construction drawings and specifications.
