Please find attached, Amendment No.1 to Licence No. **3BM-HAL1520**, Type “B”, issued to the Hamlet of Hall Beach by the Nunavut Water Board (the NWB or the Board) under **Motion 2015-B1-019**, pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*. The terms and conditions of the original Licence related to Water use and Waste disposal remain an integral part of this approval.

The Licensee is advised that this Amendment is for an undertaking that is located outside the regions of the two approved land use plans¹ as determined by the Nunavut Planning Commission (NPC) and exempt from the requirements of screening by the Nunavut Impact Review Board (NIRB)² in accordance with Schedule 12-1 of the *Nunavut Land Claim Agreement (NLCA)*.

DECISION

Licence No. 3BM-HAL1520, issued on April 30, 2015 and set to expire on April 29, 2020, shall be amended to allow for the use of Water and the deposit of Waste during the expansion and rehabilitation of the Sewage Disposal Facility operated by the Hamlet of Hall Beach (the Hamlet or the Licensee), which is located within the Qikiqtani Region of Nunavut.

On May 21, 2015, the Nunavut Water Board (the NWB or the Board) received from the Government of Nunavut Community and Government Services (GN-GCS) on behalf of the Hamlet of Hall Beach, an application and supporting information (Application) to amend Licence No. 3BM-HAL1520 for the purposes mentioned above. The Application included the following documents:

- Amendment Application signed by the Senior Administrative Officer (SAO) of the Hamlet of Hall Beach;
- Authorization letter by SAO;
- A \$30.00 Cheque payable to “Receiver General for Canada”;
- Technical Summary in English and Inuktitut;
- Design Brief ;
- Geotechnical Report;
- Construction Drawings;
- Construction Schedule;
- Construction Specifications; and
- Annual Report 2014.

Following receipt and an internal preliminary review, the NWB distributed the Application on May 28, 2015 for a thirty-day (30) public review period with the deadline for comments set for June 28, 2015. Prior to the deadline for submission comments were received from Aboriginal Affairs and Northern Development Canada (AANDC), which recommended that adequate procedures consistent with industry standards be implemented by the Licensee for managing the Waste generated during the proposed



upgrades and that an updated Operations and Maintenance Manual for the Sewage Disposal Facility be submitted following completion of the upgrades.

Apart from the intervener's comments received, the NWB received the Nunavut Planning Commission's (NPC) Land Use Conformity Determination for the file on June 9, 2015 and the Nunavut Impact Review Board's (NIRB) Screening Exemption Decision on June 5, 2015.

The NWB, having considered the information provided in support of the Application and the comments received from parties during the review process, and pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters and the Nunavut Surface Rights Tribunal Act*, hereby grants Amendment No.1 to Licence No. 3BM-HAL1520. The amendment is subject to the following terms and conditions that are based on the comments received, and standard conditions imposed by the NWB for similar undertakings:

PART D **CONDITIONS APPLYING TO WASTE DISPOSAL**

Insert Item 10

The Licensee shall submit to the Board for review, within thirty (30) days prior to commencing proposed upgrades to the Sewage Disposal Facility, a detailed set of procedures to be implemented for managing the Waste generated during the proposed activities.

PART E **CONDITIONS APPLYING TO MODIFICATION AND CONSTRUCTION**

Insert Item 6

The Licensee is authorized to undertake the upgrades proposed for the Sewage Disposal Facility that includes the expansion and rehabilitation of the facility as described in the Application received by the Board on May 21, 2015.

Insert Item 7

The Licensee shall submit to the Board for review, within thirty (30) days prior to the upgrades authorized under Part E, item 6, for-construction plans and drawings related to the upgrades, which are signed and stamped by an Engineer.



Insert Item 8

The Licensee shall, within ninety (90) days of completion of the upgrades to the Sewage Disposal Facility, submit to the Board for review, a Construction Summary Report accompanied by as-built plans and drawings, signed and stamped by Engineer, and detailed explanation reflecting any deviations from construction drawings taking into account construction and field decisions and how they may affect the performance of engineered facilities.

PART F CONDITIONS APPLYING TO OPERATION AND MAINTENANCE

Insert Item 9

The Licensee shall update the document entitled *Hamlet of Hall Beach, Sewage Treatment Facility Operation and Maintenance Manual*, dated June 2011 and approved under Part F, Item 1 in the Licence, to include the relevant changes to be carried out under the proposed upgrades to the Sewage Disposal Facility. The updated Manual shall be submitted to the Board for review with the 2015 Annual Report.

All remaining terms and conditions of Licence No. 3BM-HAL1520, Type ‘B’, issued April 30, 2015, are still applicable.
