Hi Assol

I believe DFO provided comments on this application during the NIRB review. It's my understanding that the proponents had completed a fish habitat assessment last year to determine whether it supported fish. Based on the habitat observations and the sampling results, DFO was satisfied that the pond is not fish-bearing and would not sustain a fish population; thus, removing DFO from the project review process.

Should plans change or if the proponent has omitted some information in the proposal, further review by the Program may be required. However, I'm uncertain whether there have been any project changes that would require our review. As always, it remains the responsibility of the proponent to remain in compliance with the Fisheries Act and the Species at Risk Act.

Please be advised that under the Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement) Article 11, Section 11.5.9 and s. 76 (1) of Nunavut Planning and Project Assessment Act (NuPPAA), the proponent of a project governed by NuPPAA is also required to submit a project proposal document directly to the Nunavut Planning Commission (NPC or Commission) for the NPC's determination regarding the applicable land use planning requirements and/or directions regarding whether the project is subject to screening by the Nunavut Impact Review Board. In particular, please note that as established under Articles 11, 12 and 13 of the Nunavut Agreement, NuPPAA and Part 3 of the Nunavut Waters and Nunavut Surface Rights Tribunal Act, until the project has completed the applicable land use planning and assessment process required by the NPC and the NIRB, the NWB cannot issue a water licence/approval.

The NWB confirms receipt of NPC conformity under NuPPAA on November 15, 2022 and NIRB determination through NPC under NuPPAA on April 21, 2023. This application is now ready for review and comments. Deadline for submissions is July 11, 2023.
