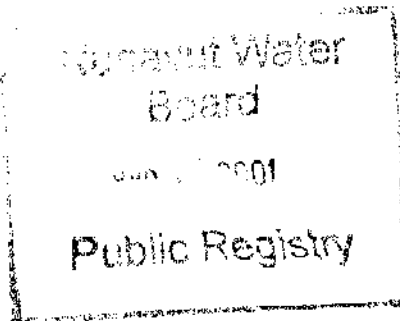
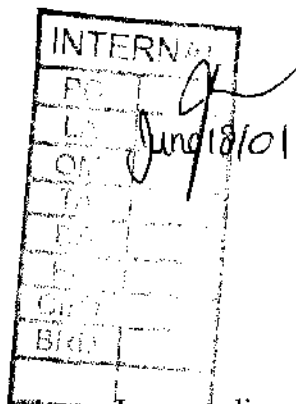

You will have to read through your new licence to verify what is required on your Annual Reports for the years 2001 and beyond.

- D) A description of any restoration or reclamation work carried out at areas where water supply or waste disposal facilities have been abandoned.

- E) Tabular summaries of all data generated under the "Surveillance Network Program." Attached with this Annual Report should be the results of the year in report's analysis at SNP

Station 1441-4, which is the run-off from the sewage disposal area on the beach, just prior to discharge into the ocean. The parameters to be measured are listed in the Water Licence N5L4-1441, under SNP Part B, Item 1.

- F) List all unauthorized discharges and spills.

- G) List any other details on water use or waste disposal requested by the Board by November 1st of the year being reported.
