The Nunavut Impact Review Board (NIRB) is in receipt of project information from the Department of PublicWorks and Services, Kitikmeot Region for the above-noted project. This package included a completed Department of Fisheries and Oceans (DFO) Fish Habitat Authorization application, as well as a number of appendices which describe the project and its three (3) major components as: 1) Breakwater and Causeway/Docking Facility, 2) Marshalling Area and Access Road, and, 3) Fuel Pipeline.

As you are probably aware, section 1.1.1 of the Nunavut Land Claims Agreement defines project proposal to include:

*... a physical work that a proponent proposes to construct, operate, modify, decommission, abandon or otherwise carry out, or a physical activity that a proponent proposes to undertake or otherwise carry out [within the Nunavut Settlement Area]"

Thus far, the only application completed and filed with this Board for the above-named project proposal is the DFO authorization. Thus, the purpose of this letter is to identify additional agencies or approving authorities who may be required to issue permits or any other authorization for this project. Examples can include DIAND, who could be issuing leases of various types; CG&T for a variety of community or transportation permits; NtlResCAN, relative to explosives storage for the blasting, and etcetera.

In summary, if the above-listed project proposal requires any authorization from your organization, please advise the Board in writing no later than Friday December 6, 2002 so that we may process the screening accordingly.
