Dear Mr. Alam:

The Nunavut Water Board (NWB or Board) has completed its preliminary review of the above-mentioned application, which determined that the following items must be addressed before the NWB could proceed to the next stage(s) of the licensing process for the application:

1. Submission of an operation and maintenance plan for the Sewage and Solid Waste Disposal Facilities as required under **Part F, Item 1** in the Licence. It appears that two documents were submitted as part of the application to satisfy this requirement:

- *Interim Operation and Maintenance (O&M) Plan, Solid Waste Management Facility, Hamlet of Repulse Bay (2006);* and
- *Long Term Sustainable Plan, Solid Waste Management Facility for the Hamlet of Repulse Bay (2009).*

The above-mentioned documents, however, do not meet the requirements for approval under any potential renewal licence that may be issued to the hamlet. In addition to requiring updated information, the Interim O&M Plan indicates that it is a temporary document that would be revised to meet requirements for approval by the Board. Further, the Long Term Sustainability Plan is a document that explores and evaluates potential options for managing solid waste generated by the Hamlet over time; therefore, it should not be considered as an operation and maintenance manual for any existing or future solid waste facility.

2. Submission of an Operation and Maintenance Plan for the Hamlet of Repulse Bay Landfarm Facility as required under **Part F, Item 6** in the licence.

3. Submission of as-built plans/drawings for the Landfarm Facility following issuance of the Amendment No.1 as required under **Part F, Item 10** in the licence.

4. Submission of a Quality Assurance/ Quality Control (QA/QC) plan within 120 days following issuance of the licence in accordance with **Part H, Item 6**:

5. A draft document entitled *Screening Level Environmental Assessment Sewage Facility Upgrade, Hamlet of Repulse Bay, NU (2014)* was included as part of the application. It should be noted that the NWB does not accept draft documents as part of an application.

6. All engineering drawings, whether for permitting, for construction, or as-built, should be signed and stamped by an engineer licensed to practice in Nunavut.

7. As part of the application documents, two letters of authorizations were included, indicating that the hamlet has given authority to two entities to act on its behalf. Confirmation should be provided to the Board on whether either or both entities will be acting on behalf of the hamlet with respect to this application.

8. Blocks 11, 14, and 25 of the water licence application form should be revised/updated to address the following: **Block**

**11** should address the entire scope of the application not just the landfarm and sewage lagoon facilities; the term "Other" in **Block 14** has been checked without any explanation as to what it entails, and **Block 25** does not include the proposed/requested term for the licence.
