Dear Mr. Etitiq:

The Nunavut Water Board (NWB or Board) has completed its review of the 2014 Annual Report (Report) and accompanying Monitoring Program sampling results for Licence 3BM-REP0409, submitted by Government of Nunavut, Community and Government Services (GN-CGS), for the Hamlet of Repulse Bay. The Licence 3BM-REP0409 was renewed on April 9, 2015, as Licence 3BM-REP1520.

The review determined that the Report is generally complete and consistent with the reporting requirements under Part B, Item 1 in Licence 3BM-REP0409. The review also noted that the Hamlet plans to begin construction of the new Water Treatment Plant and Sewage Lagoon in summer 2015. Related to this work the existing Water Truck Fill station will be demolished. The Hamlet also plans to decommission its contaminated soil storage area in 2015.

- 2. Part F, Item 2: An Operation and Maintenance Plan for Solid Waste Disposal Facility
- 3. Part F, Item 3: A Long-term Solid Waste Management Plan for the Hamlet of Repulse Bay.
- 4. Part F, Item 5: A stand-alone Spill Contingency Plan that addresses all Water, Sewage and Solid Waste Operations including management of Hazardous materials.
- 5. Part F, Item 6: An Operations and Maintenance Plan for the Upgraded Water Supply Facility.
- 6. Part G, Item 6: A Closure and Remediation Report for the site of the solid waste facility used prior to 2002.
- 7. Part H, Item 12: A Quality Assurance/Quality Control Plan.
