Hi Babesh,

Thank you for showing a keen interest in moving forward with the application. I look forward to your response, as mentioned I have re-reviewed the file and will provide an update and highlight some of the concerns with the application and the plan of compliance in addition and complementary to those in the letter. When addressing the letter, please consider, but not limited to, the following considerations and points.

### 1) Application

- Block 4 of the application states that Wastewater Treatment Plan completed by consulting firm as built drawing are attached
  - · No as-built drawings have been attached

### 2) The Plan of compliance (The Plan)

- · Part D, item 3, The Plan states that testing will start this summer and continue during life time of facility
  - Although Lab results have been provided with the most recent Annual Reports, it appears that no testing to demonstrate that effluent is Not
    acutely toxic has been conducted, and/ or provided to the NWB.
- Part F, item 1, The Plan states that items a, g, and g are only in compliance. (Water Distribution Facility O&M Plan, Waste Water Treatment Plant O&M Plan, Monitoring Program QA/QC plan)
  - The above mentioned plans have not been submitted to NWB and/or approved by the board.

## 2.1) New Solid Waste Technology

The Plan of compliance states a number of conditions in the license are reliant or dependent on the commissioning of new facility. The NWB has noted that the project has previously placed been on hold and resources and funding can present challenges.

Since there are so many conditions in the License that are reliant on developing and building a New Solid Waste management facility/plan.
It would be beneficial to provide a more detailed schedule/plan. Not only for the development/commissioning of the facility, but also detailed timing/schedule when the NWB could expect outstanding items that will be addressed when new facility is in place as stated in the plan of compliance, for example, O&M manuals or A&R plans to list a few items.

There are conditions in License which the licensee could potentially address immediately to be compliant with the License that does not require a Waste Management Facility.

For example, Part D, Item 6. It was one of the commitments made in the May 15, 2008 letter the NWB to be addressed immediately, instead
the plan of compliance states that no physical work was done(re: fish waste) and is waiting for design of acceptable technology for treating
waste.

As stated previously, the Plan lacks a short or long term schedule for implementation for achieving compliance and does not clearly demonstrate how the Hamlet will achieve full compliance. I look forward to working with you to try and expedite the application as efficiently as possible, please do not hesitate to contact me if you have any questions or want to discuss the file further.

Please see attached, correspondence that was sent out during the initial review of Application and the Plan of Compliance, identified were a number of items which still required further clarification.

A very general overview and summary of the file is that there a number of outstanding items required to consider the application complete, and although a Plan of Compliance has been submitted, the Plan lacks a short or long term schedule for implementation for achieving compliance.
