iv. a summary of modifications and/or major maintenance work carried out on the Water Supply and Waste Disposal Facilities, including all associated structures and facilities:

The construction for optimization of the WWTP was started in 2013 and is expected to be substantially completed in 2014. The design for water Truck fill station is at the final stage. Once the design is approved by CGS, the project will be ready for construction in summer 2014.

Spills:

- 1. 2013070, dated 2/22/2013, P50 Tank Farm, P50 Heating oil, 600L
- 2. 2013100, dated 3/26/2013, House 105, Home heating Fuel, 38L.

Once the WWTP is optimized and new waste management facility is built and commissioned, the existing ditch so called natural lagoon and the existing land fill site will be abandoned and restored. All liquid wastes of the Community are expected to be treated by the WWTP only once optimization is completed in 2014.

vii. a summary of any studies requested by the Board that relate to waste disposal, water use or reclamation, and a brief description of any future studies planned;

The studies on solid waste management were completed by Arktis Solutions Inc. A new guideline has been developed and accepted by CGS. The consultant exp Services Inc. has done some researches on alternative waste management processes like gasification, incineration etc. The Project is on hold due to funding. Hamlet is trying for segregation of wastes in summer 2014.

Wastes management in the Community are the major concerns of the Nunavut Water Board.

A Plan for Compliance was submitted to NWB as the part of water licence renewal application in August 2013. Hamlet has started extended sampling and testing program on water, wastewater and leachate. Hamlet is planning to implement CGS's new report Card in order to closely monitor the environmental facilities.

xi. FOLLOW-UP REGARDING INSPECTION/COMPLIANCE CONCERNS:

Hamlet is working with CGS for AANDC inspection report and Water Licence Compliancy. CGS is updating the Plan for Compliance based on the current situation. Hamlet is submitting 2013 annual report in time.
