RE: Project Screening requirements for Pangnirtung Sewage Treatment Planning Study

#### Dear Tanja:

Pursuant to our telephone conversation held earlier today and a subsequent conversation with Ms. Jaida Edwards, NIRB Environmental Screener, I confirm the following:

- 1. The NIRB screening will not be trigger at this time because the documentation before the Board is simply a conceptual plan and not a pre-design/final design report.
- 2. The NIRB screening can be triggered in two ways once the design reports presented
  - i. Because both the road and the sewage lagoon itself are located partially on Crown Lands, this project will require a Federal Land Use Permit from DIAND. This permit application is then subject to screening by NIRB. Additional information in this regard can be obtain from the Nunavut District Office, DIAND.
  - ii. Because the proposed modification is inconsistent with the existing terms of the licence, the licensee will also be required to apply for an amendment to the existing licence as changes to Part C, Item 1, will be required. This amendment request is then subject to screening because the proposed activity is located outside the municipal boundaries. This project is not exempt under Schedule 12-1 of the *Nunavut Land Claims Agreement*.
