The Nunavut Water Board (NWB or Board) has completed its review of the application and supporting documents submitted by the Government of Nunavut - Community and Government Services on behalf of the Hamlet of Pond Inlet for the renewal of licence 3BM-PON1012.

Your submission consists of the following documents:

- 2007 2011 Annual Reports

The review of the application determined that the following items must be addressed before the NWB could proceed to the next stage(s) of the licensing process for the application:

- 1. Copy of the of the Solid Waste Disposal Facility Report, required under Part F, Item 1 in the Licence
- 2. Copy of the updated, consolidated Operations and Maintenance Manual, required under Part F, Item 2, in the Licence
- 3. Copy of an analyst approval for the Quality Control/Quality Assurance Plan, as required under Part H, Item 13 in the Licence
- 4. An copy of an updated compliance plan for the Licence
- 5. Standalone copies of laboratory results for 2012, and 2013. Copies of the results, provided as embedded documents in the respective annual reports, are not viewable.

Apart from the above and as mentioned in our most recent meeting, the NWB recommends that the application for the Hamlet of Pond Inlet, "Water Crossing Project" be included under the scope of this renewal application.
