Hi Mr. Roy:

The Nunavut Water Board (NWB or Board) has completed its preliminary review of the application submitted by the Government of Nunavut – Department of Community and Government Services on behalf of the Hamlet of Pond Inlet for the renewal and amendment of Licence 3BM-PON1012. The review determined that the following documents are either missing from the application or inaccessible and should be submitted at your earliest convenience so that the application could proceed to the next stage(s) of the licensing process:

- A-1. Authorization Letter to the Municipal Planning Engineer from the SAO of Pond Inlet
- A-2. Plan for Compliance for the Hamlet of Pond Inlet
  - **A-3.** Copies of the laboratory results associated with the 2012 and 2013 Annual Reports as the ones embedded in the Annual Reports cannot be accessed or opened.

Apart from the above, the Board notes that the Licensee indicated in its cover letter accompanying the application that the following documents have been submitted previously and should be considered as part of the application:

- **B-1.** O&M manual of Sewage Treatment Facility (Sewage Lagoon), which apparently also contains a Sludge Management Plan.
- **B-2.** O&M manual for the existing Water Supply Facility (WTFS)
- B-3. O&M Manual of the Land Farm
- **B-4.** Dye test by Arktis Solutions Inc. in Sewage Lagoon

The NWB, however, requests that the Licensee provide more specific guidance with respect to any previous documents that should be considered under the renewal and amendment application as the following documents have been noted during the preliminary review:

- A version of the O&M manual for the Sewerage Lagoon Facility (B-1), dated March 7, 2005 that was submitted before the currently expired Licence 3BM-PON1012 was issued in 2012
- A copy of the O&M Manual (B-2) for the existing Water Supply Facility was not seen in the file
- A version of the O&M Manual (B-3) on file dated January 26, 2009 and submitted before the currently expired Licence 3BM-PON1012 was issued in 2012
- A copy of Pond Inlet Sewage Lagoon Dye Test Technical Report (B-4) dated November 6, 2012 was seen on file

Apart from the above, the NWB requests confirmation on whether the requirements of Part F, Item 1, submission of a Solid Waste Disposal Facilities Update Report, and the relevant inspections reports required under Part F, Item 3 have been addressed.

Further, the Licensee should note that the NIRB and NPC's determinations will be required as part of the licensing process.
