Hi Phyllis/Dionne,

I just want to this time to bring you up-to-date on our course of action to deal with the non-compliance issues with Pond Inlet with the terms and condition of the municipal water license.

With regard to seepage from the Pond Inlet Sewage Lagoon, we will be commissioning a study during the summer of 2010 to determine that cause of the seepage and we will take correction action to rectify the problem.

We have analyzed the inspection findings from INAC for the non-compliance issues for the Nunavut Waste Management sites. The findings noted for the Pond Inlet municipal solid waste site seems to be consistent across Nunavut. To address these issues, our first step is to issue an RFP to commission a comprehensive review of the municipal solid waste sites to develop a long-term municipal waste management strategy to improve the management of municipal solid waste sites. The RFP will be issued within the two- to-three weeks.

We have completed an action plan to address other non-compliance issues with our sewage treatment. We will prioritize non-compliance issues for our sewage waste treatment and we will utilize the gas funds to address these issues where possible.

Our Deputy Minister will meet with officials from INAC to discuss the existing non-compliance issues next month and the action that GN will undertake to address this ongoing issue.
