#### Reminder to submit Annual Report for Water Licence

Indian and Northern Affairs Canada (INAC) is responsible for enforcing provisions of the *Northwest Territories Waters Act*, which requires municipal operations have a valid water licence. This licence is issued by the Nunavut Water Board (NWB) under the *Nunavut Land Claims Agreement*, which also requires that municipalities possess a water licence.

Accordingly, INAC is charged with enforcing your community's water licence NWB3PON9904. As such, we are taking the opportunity to remind you that, according to Part B, Item 1 of your water licence, the Municipality of Pond Inlet must file an annual report with the NWB by no later than March 31. In anticipation of - and in order to assist you insubmitting the annual report, please find attached a copy of a form that, if properly completed, can fulfill the requirements of your annual report.

Additionally, according to the Water Resources Officer's latest inspection report sent to the Municipality on September 19, 2001, the Municipality has still not submitted its required annual reports for 1999 and 2000. By filling out an additional copy of the attached form for each of those years, the Municipality can remedy this outstanding issue of noncompliance.



Likewise, the Municipality is currently in non-compliance with respect to submitting its operation and maintenance plan of their sewage and solid waste disposal facilities. According to Part G, Item 1 of water licence NWB3PON9904, this plan was due on July 15, 1999.
